Please include in the subject line of your email, "Members Juried Print". Please include your last name and first initial along with the title in the name of the file.
example: **SmithJ_Painting.jpg**.

Artwork:

Giclee reproductions printed on canvas are **not** permitted. Members are invited to exhibit one work only. Entry must be original, entirely the work of the artist, executed within the last 24 months, and cannot have been previously shown at TCA.

No art may be removed from the exhibit prior to the close of the exhibition on Sunday, January 14, 2018 including sold art.

Delivery/Shipping:

Artists are responsible for shipping to and from TCA. Unsold work will be shipped back to the artist after close of the exhibition. Artists must provide a PREPAID shipping label for the return of their artwork.

The Members' Juried Exhibit is an Invitational exhibit for artist members of Tubac Center of the Arts. The Invitational passcode is **TCAMEMBER18**. **You must enter this passcode to access the application.**

Tubac Center of the Arts exhibit applications on **CaFE™** are limited to the first 149 applicants. Enter early. Don't miss this opportunity.

Read the call description then proceed to **APPLY TO THIS CALL** or My Portfolio to upload artwork samples. Checkout is the last step for ready to submit entries. Enter payment details to finalize the application.

Marvin Shaver juries the 2017-18 Members Juried show. Marvin's work has been seen in exhibitions in Britain, New York, Scottsdale, and throughout the Southwest as well as Tucson. An exhibition of his newest work will be seen at the Tubac Center of the Arts concurrently with this exhibition. .

Fees:

Members may enter up to three (3) 2d or 3d artworks. The nonrefundable entry fee is \$30, \$3 for each additional entry. Payments are made at the end of the CaFE™ entry process either via credit card online or a check mailed to the art center.

Awards:

Awards will be selected and presented in person during the opening reception. This year's awards judge is Marvin Shaver, working artist from Tucson.

Presentation:

All artwork must arrive ready to hang. If framed, work must be suitably matted, (white, black or neutral colors preferred), simply framed and firmly wired. TCA reserves the right to disqualify any selected entry upon arrival that does not meet the above requirements or is deemed unsuitable for display.

All work must be for sale. TCA will retain a 40% commission, Price work accordingly.
